<b>Promotional Period:</b>	<b>Start time/date:</b> 09:00 am AWST on 18/05/26 <b>End time/date:</b> 11:59 pm AWST on 13/06/26
<b>Eligible entrants:</b>	Entry is only open to WA residents who are 18 years of age or over.
<b>How to Enter:</b>	To enter the Promotion, the entrant must complete the following steps during the Promotional Period:  a) purchase a Pint of Carlton Dry or Carlton Dry 3.5% from the The Ashby Bar & Grill, Empire Bar, Freemasons Geraldton, The Roebuck Bay Hotel Broome or The Oxford Hotel (" <b>Participating Venues</b> "); b) receive an entry form from a staff member at the Participating Venue following a qualifying transaction; and c) scan the QR code on the entry form and fully complete the online entry form with their personal details as requested and submit the unique reference number from the entry form.  <b>Proof of Purchase:</b> The entrant must retain proof of purchase. The proof of purchase required is the unique reference number found on the entry form issued at the Participating Venue for the qualifying transaction.  The entrant must fill out the online entry form for every entry.

If an entrant fails to produce the Proof of Purchase for a specific entry or each entry, as and when requested by the Promoter, the Promoter has the right to invalidate the entrant's respective entry/entries for which Proof of Purchase cannot be provided and/or all entries submitted by that entrant and/or forfeit the entrant's right to a prize.

Any guarantee or warranty given is in addition to any relevant statutory guarantees and warranties and nothing in these Conditions of Entry restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
21. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may, in its sole discretion, cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.

22. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). If a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.
23. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Conditions of Entry. If there is a dispute concerning the conduct of the Promotion or claiming a prize, the Promoter will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved the Promoter's decision, acting reasonably, will be final.

The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence or willful misconduct) in connection with this Promotion or accepting or using any prize (or recommendation). For the sake of clarity, this clause shall not apply where the Promoter has contributed to or caused such loss, expense, damage, personal injury or death and shall not apply to any liability which cannot be excluded by law (in each case the Promoter's liability is limited to the minimum allowable by law).
